- 2. Proposal demonstrates how the program will meet the need and that the agency has the capacity to meet the need.
- 3. Proposal is targeted primarily to ALICE\* families in Charlotte County. (\*Asset Limited, Income Constrained, Employed)
- 4. Proposal aligns with the UWCC mission to break the cycle of poverty.
- 5. Proposal directly identifies and addresses an aligned contribution to one of the strategic priorities (Educational Success, Financial Empowerment, Seniors, and Communication & Navigation) or a basic need.

- 3. Outcome clearly demonstrates an aligned contribution to at least one of UWCC's strategic priorities or meets a basic need.
- 4. Clearly states if outcome was achieved with past funding and explains why if it was not.
- 5. Agency demonstrates ability to report demographic data on clients served.
- 6. Clearly states how Charlotte County residents will be impacted by proposed project.
- 7. Proposal demonstrates the ability to make a significant impact with this funding.

- 2. Named agencies in Charlotte County that provide similar services, stated similarities, efforts to minimize duplication, and what differentiates the program from those other similar programs.
- 3. Described formal program collaborations and included how these collaborations enhance or extend the programs services.
- 4. Provided evidence of being a strong and supportive partner with UWCC.
